

## **HPPOA Treasurer's Report**

### ***Bank Balances as of the end of June 2020:***

TOTAL Checking, Savings, Investments and Bond Reserve: \$8,130,091.80

TOTAL Accounts Receivables: \$2,470,650.10

This account balance represents unpaid road maintenance fees, lien fees, finance charges, legal fees, collection expenses and bounced check charges as well as a few transfer fees that have been billed but not paid. The office billed out approximately \$3,135,569 for the annual billing. The Accounts Receivable balance at 06/30/19 was approximate \$2,351,116.66 Based on my calculations it appears the office has collected approximately \$2,862,302.90 in the current fiscal year.

Allowance for Doubtful Accounts balance is: \$696,720.54 (This is a contra-asset account required by Generally Accepted Accounting Principles (GAAP) that records the estimated dollar amount of receivables which may not be collectible.)

There were 48 property transfers completed during the month.
