#### 1. Article VIII - Board of Directors Sec 1-12 P 8-13

**Sec 1** Number and Qualifications - Proposed new wording: "The directors must be able to attend board and membership meetings in person, serve on committees of the board **and be available for communication with other board members.**" Randi 1st, Ron H 2nd, all approved. Shall we tweak this to read "and be available for communication with other board members and **association members.**" ??? Will add this to agenda for discussion.

Sec 2 Terms - (a - e) All approved to leave as is.

**Sec 3** Districts - Proposed new wording of last sentence: "Directors shall be nominated **by members in their** district only." Randi 1st, Ron H 2nd, all approved.

Sec 4 Nomination - (a - b) All approved to leave as is. Proposed new wording for (c): "The board

shall pass all **district applications** to the Nominating Committee." and proposed new wording for (d) "**District applications** shall be submitted by the nominating committee to the Association Administration Office for preparation of the ballots. The deadline for receipt of **district applications** shall be the end of the third week of March." Mayelin 1st, Ron H 2nd, all approved new wording for (c & d).

**Sec 5** Election - Proposed new wording for (a) "**Yearly** the members in each voting district whose **rep's** term expires, or is being filled by a board appointee **because of vacancy**, shall elect a new director by confidential mail-in ballot." Ron H 1st, Randi 2nd, all approved.

Homework is to review the remaining Sections under Article VIII - Board of Directors.
