- 2. <u>Article V Bylaw Definitions Sec 19 Capital Improvement P 5</u> Milton will bring copies to our next meeting of approved draft to reflect "Sec 19" in the title area. Definition proposal final draft approved 10 Nov 2016.
- 3. <u>Article V Sec 20 Emergency</u> Milton brought a draft with proposed wording. After much discussion the verbiage agreed upon:

"A sudden unexpected or impending situation that may cause injury, loss of life, damage to property owned and/or maintained by HPPOA and/or interference with the normal HPPOA business activities which requires immediate attention and remedial action."

- 4. <u>Article VIII Sec 8 Powers and Authority (a-j ) P 10</u> Review and discussion ensued on the draft. There were corrections made on proposals for (c).
- (c) Maintain, repair, replace, restore, improve, and protect the common property, including, but not limited to, subdivision roadways, real property, buildings, equipment, and any additional improvements and alterations thereto, providing however, that any Capital Improvement (as defined in Article V, Sec 19 of theses bylaws) project in excess of \$75,000 shall be first approved by the general membership except for cases of emergency (as defined in Article V, Sec 20 of these bylaws).
- 5. <u>Article VIII Sec 8 Powers and Authority (k)</u> Reviewed drafts and discussion ensued. New verbiage approved for final draft:

"Nothing in this section shall interpreted in such a way as to relieve the board of the responsibility to account for all road funds separately in accordance with generally accepted accounting practices **principles** nor to empower the board to expend road maintenance funds for any purpose other than road maintenance activities."

More discussion ensued in it's affect in another area of the bylaws.
