- **I. Call to Order:** Leilani Bronson-Crelly (Chair) called the meeting to order at 4 pm on March 21, 2017 at the HPPOA Library.

- **III. Approval of March 7, 2017 Minutes**. Approved unanimously and Alexa (Secretary) directed to submit the Minutes to HPPOA Office via e-mail. Receipt confirmed by Bridget.

#### IV. Old Business:

- a) **Update on County Council Hearing on Resolution No. 82-17** attended and testimonies provided by Leilani, Mary and Alexa (as private HPP lot owners). Dept. of Transportation denied the release of \$15,000 000 for the project to the County of Hawaii Dept. of Public Works before this appropriation expires on June 30, 2017. While this decision momentarily averts the building of a busy highway through HPP, we need to stay informed of current developments in Puna regarding connectivity issues.
- b) Leilani, Mary, Mike and Alexa attended the PCDPAC Town Meeting at Pahoa Community Center on Tuesday, March 14. The Members listened to concerns of other communities and offered their testimonies, as well. Out of the **Six Priorities**, **Connectivity of Puna Subdivisions** is # 2. It was decided that we should attend these town meetings to stay informed and to offer our input as HPP's PMAR Committee. The next meeting of Puna communities is on March 28, 2017 from 2-4 pm at the Keaau Community Center.
- c) **Definition of PMAR Stakeholders** (Report by Leilani Bronson-Crelly). Entities concerned include, but are not limited to: Hawaiian Homelands (Panaewa, Maku'u, etc), Shipman Estate, lot owners in private subdivisions (as in HPP). Leilani is working on setting a meeting with Bill Walter, President of the Shipman Estate.
- d) Review of the Hawaii County Puna Community Development Plan (2010/11). Report by Alexa.
