This account balance represents unpaid road maintenance fees, lien fees, finance charges, legal fees, collection expenses and bounced check charges as well as a few transfer fees that have been billed but not paid. The Accounts Receivable balance at 8/31/2019 was approximate \$2,297,924.77. Based on my calculations it appears the office has collected approximately \$261,913.23 in the current fiscal year.

Allowance for Doubtful Accounts balance is: \$642,622.64(This is a contra-asset account required by Generally Accepted Accounting Principles (GAAP) that records the estimated dollar amount of receivables which may not be collectible.)
