Allowance for Doubtful Accounts balance is: \$626,238.95 (This is a contra-asset account required by Generally Accepted Accounting Principles (GAAP) that records the estimated dollar amount of receivables which may not be collectible.)

There were approximately 57 property transfers during the month of May.
