# 7. GM's Report-Don Morris

Don Morris reported the following:

The road crew will start installing C-88 two-way yellow reflectors on Shower Drive next week weather permitting

The request for proposals for repaving Pohaku Circle and Paving 18<sup>th</sup> MPDE and PMDE should be sent out by the end of the month

The repairing, replacing and installation of new road signage will begin sometime after the new year when our new hammer for the backhoe arrives.

We are buying some newer equipment to replace some of our older and non-working equipment such as a new hammer for the backhoe. A bigger single axle dump truck and a new John Deere Gator to replace the cub cadet that is hard to get parts for.

Equipment: The Scag deck mower is still down waiting for parts. The new Hammer for the Backhoe has been ordered. It will be here in two to three months; other equipment was maintained as needed.

Mowing: The road crew mowed 47 miles of roadway easement with the sidearm mower.

Grading: Widen, dropped 1 1/2" base course graded and compacted 12 miles of roadway.

Weedwacking: Corners, signs, and mailboxes on Makuu, Paradise, Kaloli, Paradise Ala Kai, and Lemiwai.

Rubbish Pickup: .60 tons of mixed rubbish, 14 Tires, 11 Rims

Dead Animals: 3 pigs removed

Safety Report: No accidents or injuries for the past 83 months

As per previous discussions regarding street signage, Kari Hoffman (District 5) moved to have the General Manager, Don Morris, investigate options for two-sided, reflective, uniform, numbered street signs at least 8 ½ by 11 inches or 9 by 12 inches in size, in compliance with applicable laws and to provide cost estimates and samples to the Board of Directors.
