The annual Presidents report and road maintenance billings have all been sent out. The office is very busy at this time processing payments.

Grading: Widened, dropped 1 1/2" base course and compacted 11.5 miles of roadway.

Hot Mix: Filled holes with hot mix on Pohaku, 33MDE, 32MDE, 29K-HWY, 28KS, 27KS, 26MP, 26PK and 23KS.

Weedwacking: Corners of Paradise Ala Kai, Lemiwai, Pillikai, ABC's Paradise, Kaloli, Shower and mailboxes.

Trees Removed: 26KS AND 7 KDE

Rubbish Pickup: .92 tons of mixed rubbish and 1.27 tons of scrap metal.

Dead Animals: Removed 4 pigs, 1 dog, 1 cat and fish parts.

Abandoned Vehicles: 9 vehicles removed
