Bank Balances as of the end of June 2022:

TOTAL Checking, Savings, Investments and Bond Reserve: \$8,141,474.98

TOTAL Accounts Receivables: \$2,960,406.92

This account balance represents unpaid road maintenance fees, lien fees, finance charges, legal fees, collection expenses and bounced check charges as well as a few transfer fees that have been billed but not paid. The Accounts Receivable balance at 6/2021 was approximately \$2,572,711.80. The annual billing for this year was approximately \$3,469,752.00

Allowance for Doubtful Accounts balance is: \$608,357.49 (This is a contra-asset account required by Generally Accepted Accounting Principles (GAAP) that records the estimated dollar amount of receivables which may not be collectible.)

There were approximately 86 property transfers during the month of June
