

***HPPOA Treasurer's Report
October 18, 2023***

Bank Balances as of the end of September 2023:

TOTAL Checking, Savings, Investments and Bond Reserve: \$7,003,153.71.

TOTAL Accounts Receivables: \$3,029,437.01.

This account balance represents unpaid road maintenance fees, lien fees, finance charges, legal fees, collection expenses and bounced check charges as well as a few transfer fees that have been billed but not paid. The Accounts Receivable balance at 09/2022 was \$2,694,435.62. The annual billing for this year was \$3,447,576.00. As of October 12th, we had a total of 7,085 owners paid in full or 80.1%. We took in \$814,052 in dues in February; \$1,196,319 in March, \$618,612 in April, \$155,368 in May, \$67,226 in June, \$148,725 in July, \$102,418 in August, and \$72,490 in September for a total of \$3,175,211.

Allowance for Doubtful Accounts balance is: \$893,049. (This is a contra-asset account required by Generally Accepted Accounting Principles (GAAP) that records the estimated dollar amount of receivables which may not be collectible.)

There were approximately 55 property transfers during the month of August.
