***Bank Balances as of the end of February 2026:***

TOTAL Checking, Savings, Investments and Bond Reserve: \$6,750,782.58

TOTAL Accounts Receivables: \$6,166,065.37

This account balance represents unpaid road maintenance fees, lien fees, finance charges, legal fees, collection expenses and bounced check charges as well as a few transfer fees that have been billed but not paid. The Accounts Receivable balance at 2/2025 was \$5,880,947.63. The annual billing for this year was \$3,807,990. As of February 2026, we had a total of 2,888 owners paid in full or 32.6%. We collected \$239,501.33 in fees in January and \$786,073.25 in February.

Allowance for Doubtful Accounts balance is: \$430,224.75. (This is a contra-asset account required by Generally Accepted Accounting Principles (GAAP) that records the estimated dollar amount of receivables which may not be collectible.)

There were approximately 37 property transfers during the month of January.
