Over 1500 surveys were received and they are still trickling in. Thank you so much for completing the surveys and your comments. It has provided new information for the Board to use in making future decisions. Not all questions were answered on every survey. The first four lines in the chart above indicate how many were received from either owners living in Hawaii or elsewhere and whether their property is located on a paved or unpaved road.

The question as to whether or not to continue paving the roads is split about 50/50, but a commitment to agree to an assessment of any kind was only 31%. The most popular of the options was \$300 for 8 years. Voting for more than one assessment were 138 owners and 16 said they would agree only if promised that their road would be paved. Therefore:

- 630 total votes for an assessment
- -138 double choices
- 16 contingent upon their road being paved
- 466 net total (31%)

Many who live on unpaved roads indicated that they bought their homes in HPP because it is rural and they prefer to keep it that way. More of the people who preferred their road to stay unpaved live in the lower end of the Park. There were many comments regarding the fact that owners who are complaining about the dust knew what they were buying. Quite a few of the long-time residents who lived here during the days when all the roads were unpaved stated that they planted hedges of vegetation to combat the dust and through the years have found that to be very effective.

Some of you wrote about specific concerns and every effort is being made to address those issues. Over 60 people who live in the area have indicated that they would be willing to volunteer. Those names have been given to Skip McAlister, the Vice President, and he is determining the areas of help needed.

This survey asked for owner concerns and to no surprise, speeding cars was the most often mentioned problem. Finance was a close second. There were quite a few expressing interest in bike and walking paths and there now is a new committee exploring how to accomplish this. Albezia trees remain a constant problem for many. The Association is making every effort to watch for those on our easements, but there is nothing we can do with those on private property.

There has been an increase in "tent cities" and the Association has reported a number of them to the Department of Public Works. Because there is only one inspector for all of Puna, little effort has been made to investigate these situations. Squatters in abandoned or foreclosed properties are another issue that also has been referred to this Dept.
